Consistent with the Stage 4 lockdown in the second half of 2020 the Victorian Government has formed a view that only a limited number of specifically listed providers can remain open.

If your outlet falls under one of the above 'Required to Close' categories, you are required to close in accordance with the Circuit Breaker Action requirements. Whilst your terminal will remain operational during this time, reports on terminal activity will be actively monitored to ensure compliance with the Victorian Government Health Directive. We reserve the right to take action under your franchise agreement should you choose not to comply.

If you have not done already, please immediately cancel any Store and Group Syndicates where none of the shares in those syndicates have been sold. For Store and Group Syndicates that you have already sold shares in, ensure your staff offer to all customers up until you have to temporarily close your outlet.
